1. ENTRIES

Team entries must be made on the official entry form by each FMN and sent to the FIM Administration.

All entries must be received by 16.08.2011.

2. TECHNICAL CONTROL AND REGISTRATION

The administrative and technical control will take place on Saturday 17.09.2011 between 09:00 and 12:30.

Each machine must be road legal for the country in which it is registered, and comply with all requirements of the FIM Technical regulations including those under Art. 053.8.1. Parts will be marked in accordance with Art. 053.8.4. Sound level control will be carried out in accordance with Art. 053.8.3.

At administration control, all riders in the World Championship must submit their FIM World Championship licence and all riders in the International Trophy must submit their FIM World Championship licence or Continental Championship or International licence, valid for the event.

At the technical control, all riders must submit the administrative documents of their motorcycles and a helmet, according to the FIM standards.

3. BIBS

The riders must wear the bib given by the CTR.

Names of the sponsors displayed on the official bibs are:

The starting number will be the same as the teams placing in the FIM Trial des Nations classification of the previous year.

4. START

The starting order will be decided according to Art. 053.7.7.

Each team member will have the same starting time.

The last team will depart at 11:00.

The start interval between the teams will be 8 minutes.

5. COURSE AND TIME

The length of the course is of 13 km for all participants.

The course will consist of TWO laps of 18 sections for all participants.

The total time limit for each team will be determined by the International Jury.

6. PADDOCK AND PRACTICE

The Paddock will be opened to all riders from Wednesday 14.09 (13:00 - Big trucks, 15:00 - others).

The practice times will be displayed at the official notice boards. Any rider found practising outside the areas set aside by the organisers will not be allowed to start.

7. HEADQUARTERS AND JURY MEETINGS

The Headquarters for the event will be the Secretariat building, Piazza Centa and Jury Meetings will be held in the same building.

The meeting with the organisers and the Jury President and/or the CTR Representative will be held on Wednesday before the event at 18:00.

The first Jury meeting will be held on Saturday before the event at 16:45.

8. AWARDS

Awards will be presented to each member and to the FMN of the first 3 placed teams for the World Championship and the International Trophy.

9. PRIZE-GIVING CEREMONY

The Prize-Giving Ceremony will take place in the start area within 15 minutes of the final classified team arriving at the finish.

10. ADDITIONAL INFORMATION

The teams' presentation will be held on 16.09.2011 at 19:00 in the Main square (Piazza XX Settembre) - good weather; in the City Theatre - bad weather.
