Starting number will be given by the organizer, the background of the number plates have to be prepared by the rider in accordance with the rules.

TECHNICAL INSPECTION

The technical inspection will take place on at BÉR **27th MAY 2011. from 16.00 to 19.00. and 28. MAY 2011. from 08.00 to 08.30.**

Each machine must comply with all requirements of the UEM Sporting Code and relevant Appendices, including those under art.01.14. Instruct parts will be marked in accordance with art. 01.16. A noise test will be carried out in accordance with the Technical Rules. All riders must present his helmet.

STARTING ORDER

All riders from UEM CUP start together.

COURSE

The race is 2 hours/day on 8 km long track.

PENALTY

Penalties to be in accordance with art. 01.47.

The first meeting will be held on 27th MAY at 15.00 in BÉR in the Jury room. Subsequent Jury meetings will be at times decided by the Referee and these times will be displayed on the Jury room door.

PRIZE GIVING CEREMONY






